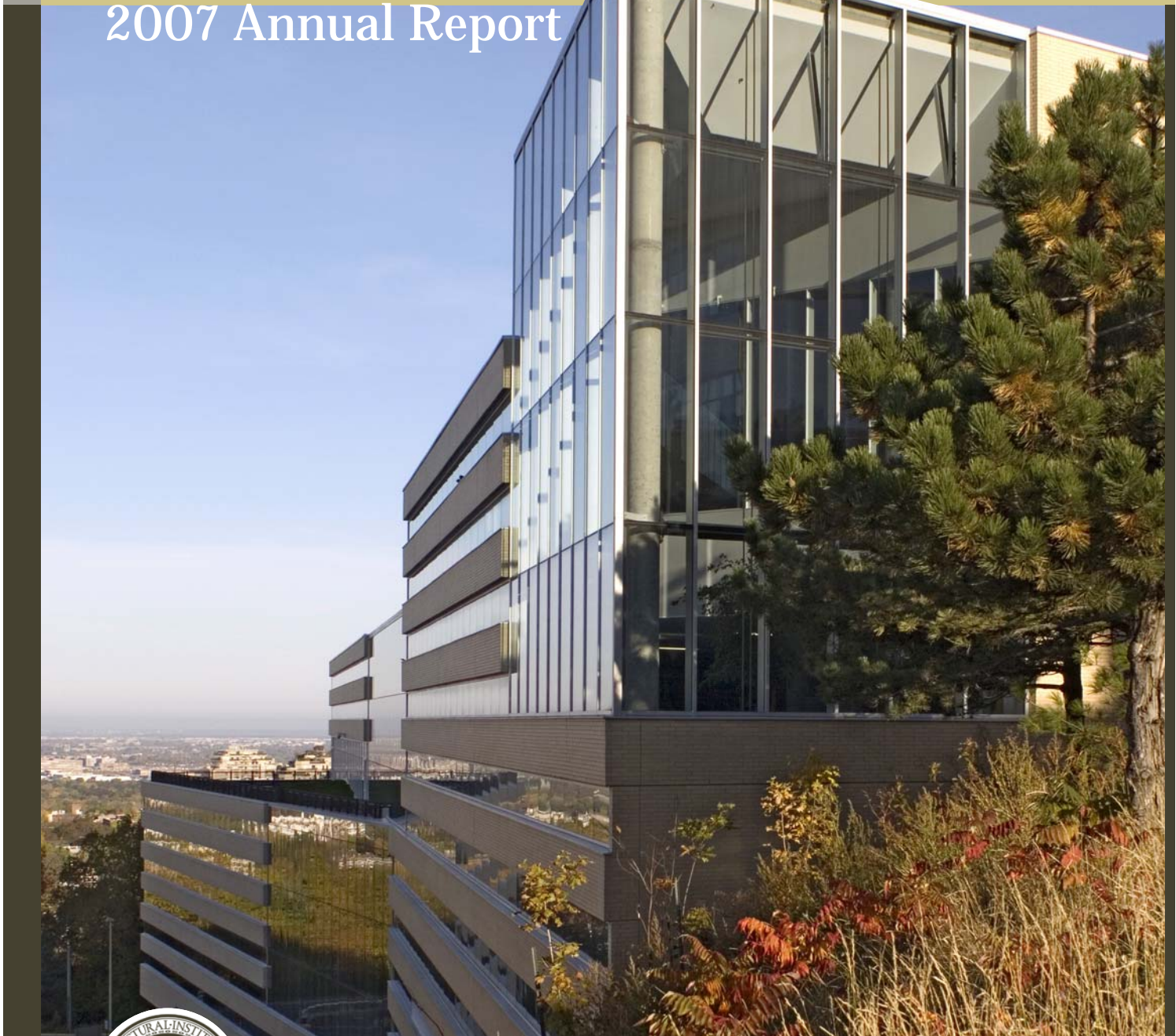

President's Report



I would like to begin my report by saying thank you to **Vivian Manasc, PP/FRAIC**, the Immediate Past President, and all of our Past Presidents, Boards and volunteers for building a strong and progressive RAIC. I was indeed very honoured to be given an opportunity to continue and to further the accomplishments of our great institute.

As I take stock midway through my year as president, and reflect on my initial thoughts, I am pleased to see that as we roll out of our centennial year our profession is re-energized as it prepares for the next one hundred years.

Our predecessors had foresight. They came together because they knew there was strength in numbers and strength in speaking with one voice.

A quote from the first report of the Secretary in Montreal dated May 18, 1907 by Alcide Chaussé, details the reasons behind the creation of the Institute:

"In view of the rapid increase and enlargement of building operation in the Dominion of Canada and the consequent development of architectural interests, it is thought by some architects that the time has arrived for the organization of a society embracing the whole Dominion.

It is also felt that such a society has become a necessity in order to promote and conserve the honour and dignity of the profession."

That statement is not far from the truth today. Take a good look at the Profession – everybody is busy, very productive, and there is plenty of work. That doesn't leave a lot of time for individuals to foster the Profession.

This has provided an excellent opportunity for the RAIC to take on this role, working co-operatively with associations, provincial, territorial and others, to improve our profession and better the environment, our neighbourhoods, communities, cities – Canada from coast-to-coast-to-coast.

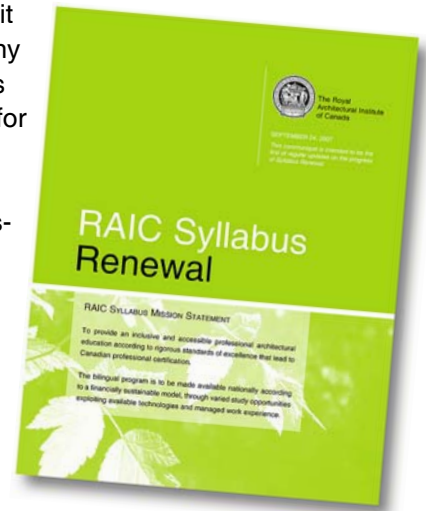
I am pleased to say that we are working with all the provincial and territorial associations in dealing with national issues. In fact, I have personally visited with each and every one of them in their home offices. These meetings offered a unique perspective on the challenges each faces and the ways in which RAIC can work with them and enhance the profession in each province and territory. The future of the RAIC is in the grassroots and from my perspective establishing RAIC Chapters in all regions is a must.

One of the key successes of these meetings and the Roundtables RAIC has been hosting, is the Harmonization of Continuing Education and the development of the Harmonized Continuing Education National Database. All provincial and territorial associations have reached an agreement in principle with contents of Quality Assurance Document. Currently under development, this national

database will be accessible by all provincial and territorial associations and their individual members to be maintained and track continuing education accomplishments.

One of our major accomplishments this year – and I can only say that it was my good fortune to steward this process which was begun by many before me – is the RAIC Syllabus Renewal. It has been a long process but, to put it succinctly, in order to meet the educational requirements for licensure consistent with those of recognized University Schools of Architecture the Syllabus program will now be offered through a partnership with Athabasca University, a state-of-the-art and innovative distance education expert with proven experience and an open university policy. Following an extensive review of potential program concepts, a four-year Bachelor of Science degree plus a two-year graduate diploma has been found to best accommodate the existing Syllabus program.

From the beginning, the goal was to cause little disruption to our existing students and offer the program in both English and French. I am pleased to say we are well on our way to accomplishing both. I would like to thank **Ian MacDonald, FRAIC**, who has been the leader of this initiative and each member of the Program Advisory Council. All of them have spent countless days in bringing this new program to near fruition.

Our continuing effort in the globalization of the architectural profession is worth mentioning. We maintain good relationships with international architectural associations, AIA (the American Institute of Architects), FCARM (the Federación des Colegios des Arquitectos de la República Mexicana), RAIA (the Royal Australian Institute of Architects), UIA (the Union internationale des architectes), and APEC Architect Project (the Asia Pacific Economic Cooperation).

The RAIC's Task Force on the 2030 Challenge is working extremely hard to map out a strategy for achieving the Challenge's ultimate goal: all new buildings no longer requiring the use of fossil fuel energy or emitting green house gases by 2030.

A key focus for my tenure has been increasing membership and reaching out to the various categories of possible members. It is part of my belief that each new member is a step towards building a greater Institute – a greater Institute than the founders ever envisioned when they came together in 1907. And I am proud to say we boast almost 3,700 members this year – part of a steadily increasing total which is seeing more and more in the profession embrace the goals of the RAIC and join us in creating a louder voice.

I believe RAIC can raise up the Profession, while the Architects build Canada. By working together – with each Architect adding to this goal – we in Canada can have this great profession.

Credits for all of our accomplishments this year go to our Board of Directors and its Executive Committee, tireless work by our Executive Director, **Jon Hobbs, FRAIC** and each and every staff at our National Office. And, of course, many volunteers who served on Task Forces and Committees for making our profession more relevant.



As we complete the celebration of our first one hundred years, I feel a tremendous pride and responsibility as an Architect and have been honoured to continue to carry the torch that was lit back in 1907.

As we look at our accomplishments for 2007 I think we have served the profession well and that our forefathers would be pleased with our progress and determination.

Together we can be a strong voice for architecture and its practice in Canada.

Executive Director's Report



2007 was another banner year for the RAIC.

Our membership continues to grow, as do our services and our member benefits. We now boast almost 3,700 members. Nevertheless, with nearly 7,000 registered Architects in Canada and some 2,860 Interns and Intern Architects, we still have a way to go.

Also, in 2007 the RAIC was able to add modestly to our reserves with net revenues of \$61,169. Our total reserve is now \$299,302. A general rule of thumb is that not-for-profit organizations should have a reserve of about one-half of their annual operating expenses. Realistically we should be aiming for a reserve of about \$350,000 to \$400,000, but we are fast approaching this goal.

The RAIC was also able to increase our staff by one additional person – hiring a new Communications staff member to help manage our website, the RAIC e-bulletin and other outreach activities. Our next goal is to hire an Architect who could promote architectural competitions and provide more practice support for certain committees and to members seeking advice.

Advocacy and Communications continue to expand with more media releases, more columns and articles in various trade publications, and more newspaper coverage about architecture. We also led some modest campaigns to further promote Architecture to the general public.

In addition, our Honours and Awards program continued to grow with two new awards in 2007 – the President's Award for Architectural Journalism and the Prix du XX^e siècle.

Internationally the RAIC continues to make a presence for Canadian Architects with increased participation at the Union internationale des architectes (UIA) and more contacts with other international associations of Architects. And this year we were able to send one additional RAIC member to the popular Marmomacc event in Verona, Italy!

Finally, we celebrated our centennial year with several modest activities. Most notably was the issuance of a postage stamp by Canada Post featuring Canadian architecture and Architects. We also held a very successful fundraising campaign for the Centennial Fund of the RAIC Foundation to support interns and intern Architects (almost \$95,000 was raised), created the new campaign *Every Building Has an Architect* and tested a new format for professional development by partnering with the Rotman School of Management to host a half-day session, entitled *Maximizing Productivity*



and Encouraging Innovation Through Design – A workshop for thought leaders, designers and architects.

These successes are not only dependent on our dedicated staff but also on our members and the many volunteers who support the RAIC by providing the direction and professional input to sustain and grow our programs. It is to our many, many volunteers and donors that we owe our success.

Thanks to all our volunteers and members! Our centennial year was a success because of you!

Governor Generals Medals in Architecture

In the fall of 2007, the RAIC issued a Call for Submissions for the Governor General's Medals in Architecture. The Awards will be adjudicated in early 2008.

RAIC Gold Medal

The RAIC Gold Medal is awarded in recognition of significant contribution to Canadian architecture, and is the highest honour the profession of architecture in Canada can bestow. It recognizes an individual whose personal work has demonstrated exceptional excellence in the design and practice of architecture; and/or, whose work related to architecture, has demonstrated exceptional excellence in research or education.

Mario Saia, FIRAC was the recipient of the 2007 Gold Medal. In bestowing the award, the Gold Medal Selection Committee noted:

“Of the slate of significant and literate architects in Canada, there is little doubt that Mario Saia is one of the most provocative. His buildings depart from the realm of the familiar, the comfortable, the conservative. He pushes the frontiers of conventional design and incites both users and passers-by to reflect on the meaning and purpose of architecture, of city planning, and of milieu. He consistently addresses context with concern and innovation, resulting in a body of work that is diverse, creative and meaningful.”

Prix du XX^e siècle

In honour of its 100th anniversary, the Royal Architectural Institute of Canada recognized five buildings with a new award, the Prix du XX^e siècle.

This award recognizes the enduring excellence of nationally significant architecture, such as landmark buildings in the historical context of Canadian Architecture. The award can be presented to a building in Canada, designed by an Architect from any country, or a building anywhere designed by a Canadian Architect.

These landmark buildings and their Architects were announced in May 2007 during the OAA/RAIC Conference and Festival of Architecture. The following stand out for their enduring excellence:

- *Smith House 2* in West Vancouver by **Arthur Erickson, FRAIC**, Erickson/Massey

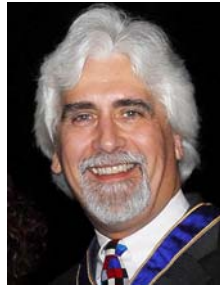

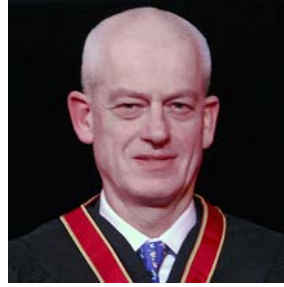

Survey – Canadian Handbook of Practice for Architects

In preparation for a full revision of the Canadian Handbook of Practice for Architects (CHOP) in 2008, the RAIC undertook a survey of members and the provincial associations to identify the best format for the updated Handbook. The new Handbook will be available electronically and paper copies still may be purchased, but at a higher price.

Document Nine

The RAIC engaged **Alex Rankin, FRAIC** to prepare revisions to *Document Nine, the Standard Form of Agreement Between Architect and Consultant*. He worked with **John Bobaljik, FRAIC** and Michael Ernest to propose final contract language to the RAIC Practice Support Committee. The Practice Support Committee then developed Schedules outlining the scope of services and deliverables for use with Structural Engineers and Mechanical and Electrical Engineers. The document was made available in both official languages and in an electronic version on the RAIC website.

Advocacy

Model Architecture Policy

The RAIC continued to advocate to institutions and municipalities about the importance of adopting a policy that ensures quality architecture that is sustainable and good urban design. In 2007, the RAIC

was pleased to provide a Certificate of Recognition to Brock University for adopting such a policy. **Raymond Moriyama, FRAIC**, Brock University Chancellor, and Jack Lightstone, President and Vice Chancellor, Brock University were presented with the certificate.

Federal Government Procurement

The RAIC, through a committee called Federal – Industry Real Property Council, works with Public Works Government Services Canada (PWGSC) and other federal departments to ensure the fair and transparent selection of Architects, and that contracts between the government and Architects are equitable and properly assign risk and responsibilities. The RAIC works closely with the Association of Canadian Engineering Companies (ACEC) in this regard and both organizations advocate for a qualifications-based selection (QBS) system.

Ralph Wiesbrock, FRAIC, Peter Kindree, MRAIC, and Deborah Farrow, MRAIC serve on the committee dealing with the Federal Government with staff support provided by **Jon Hobbs, FRAIC**.

Board of Directors

The RAIC Board of Directors and Executive Director were especially vocal in advocating for a wide range of issues including:

- disappointment with the Federal Government because it publicly issues announcements about funding energy efficiency, while quietly cutting programs such as funding for the Commercial Building Incentive Program (CBIP) for New Buildings;
- the 2030 Challenge and the need for Sustainable Design;
- the maintenance of federal initiatives to alleviate skilled labour shortages through improvements to the Temporary Foreign Worker Program;
- design of housing is much more than cookie-cutter homes (through a clip on the Slow Home website);
- the need for consultation and a Design Competition for Lansdowne Park in Ottawa; and,
- input to the Pre-Budget Consultations of the Federal Government.

Advocacy Magazine

This electronic newsletter continued to be well received as a monthly e-mail to each RAIC member fostering a sense of community and keeping everyone informed of news related to the profession, the activities of the RAIC and the Board. New features in 2007 included some streaming video, when available, intern and student news briefs, well-populated and up-to-date competitions, opportunities, and awards sections as well as a current calendar of events.

Electronic notices

Electronic notices were sent as needed to members reminding them of important events and deadlines such as Calls for Submissions, elections for Regional Directors and professional development courses.

Website

The RAIC website was updated to access more information from the home page.

New sections were included on the home page – Chapters, International, Continuing Education, Interns and Students, as well as direct links for the Site map and Online purchases. Space was provided for five “What’s New” buttons and the Search Engine was placed first in the list of direct links.

All the information on the website was reviewed and it continues to undergo maintenance and updates.

RAIC Columns

In an effort to spread the RAIC's message across many audiences, arrangements were made for columns to appear in several publications of interest to the profession. The RAIC appeared monthly in the *Daily Commercial News/Journal of Commerce*, bi-monthly in *Sustainable Architecture & Building [SABMag]* and throughout the year 2007 in *AWARD Magazine*.

To keep the perspective fresh and interesting, members of the Board participated as writers in all of the above columns.

Membership

As of December 31, 2007 the RAIC had 3,632 members (3,208 paying members). The RAIC offered free membership to all 2007 graduates from a professional degree program in Architecture. By December 31, 2007, 102 graduates had responded to the offer.

For the third year, the RAIC published an annual membership directory through an arrangement with Naylor publications. This agreement allows the Naylor sales team to promote the RAIC and enables all costs to be recovered. In return, RAIC members receive a printed annual directory.

In accordance with the RAIC's environmentally friendly policy, the membership was polled regarding the need for a printed publication, and whether an online version sufficed. Response was limited but quite clearly evenly divided.

External Relations

The RAIC organizes and funds external relations into two distinct categories: National and International Affairs.

National Affairs

President Visit to Provincial Associations and CACB

In the spring of 2007, RAIC President **Kiyoshi Matsuzaki, FRAIC** and Executive Director, **Jon Hobbs, FRAIC** toured the country and met with every provincial association of Architects. Feedback and cooperation was significant, allowing the RAIC to advance several membership and practice support initiatives.

Roundtable with Provincial Associations

The RAIC hosted and facilitated a roundtable with representatives from all the provinces and territories along with representatives from the Canadian Architectural Certification Board (CACB) for day-long discussions on the integration of International Architectural Graduates / Internationally Trained Professionals (IAGs / ITPs) and other national projects.

The following actions were agreed to:

1. Implement Automatic Canadian Architectural Certification Board Certification for all Graduates of Accredited Canadian University Schools of Architecture.
2. Update the Canadian Educational Standard.
3. Create a Task Force to develop a mechanism to evaluate experience for Internationally Trained Professionals (ITPs).
4. Prepare an update to the Canadian Handbook of Practice for Architects (CHOP) in an electronic format.
5. Complete details of a business case and proposal for a national database to record continuing education credits.
6. Provide feedback on revised Document Nine and on the new Guidelines for Architectural Competitions.



Construction industry Consultative Committee (CICC)

In August 2007, **David Simpson, PP/FRAIC, Ralph Wiesbrock, FRAIC** and **Jon Hobbs, FRAIC** attending the annual CICC meeting – with the senior elected and staff officers of the other organizations that comprise CCDC, namely the Canadian Construction Association (CCA), the Association of Canadian Engineering Companies (ACEC) and Construction Specifications Canada (CSC). The RAIC was able to get a commitment that once new alternate dispute resolution language is incorporated into RAIC standard contracts then the CCDC will commit to including enabling language in their own documents, beginning with CCDC 2, within six months.

RAIC Syllabus Renewal

The Interim Program Advisory Committee continues to work diligently on consultation, program development and a transition plan with our institutional partner, Athabasca University, to offer the renewed Syllabus program.

The renewed program will offer:

- Bachelor of Science (Architecture) – ***B.Sc. (Architecture)***
- A Post-Diploma Bachelor of Science Program (Architecture) for those with community college diplomas – ***B.Sc. (Architecture)***
- A Graduate Diploma in Architecture – ***Dipl. Architecture***

Human Resources and Social Development Canada

After completing a study through Prism Economics in February 2007, entitled *Integration and Licensure of Internationally Trained Architecture Graduates*, the RAIC applied for funding for a second phase which would undertake three distinct projects:

- A new website for Architects considering emigrating to Canada.
- Support for the revision and development of RAIC Syllabus courses.
- A new licensing system for those Architects with foreign training and experience.

The funding application was successful and in October Parliamentary Secretary, Lynne Yelich, announced officially at a joint press conference that funding for these projects would proceed.

Canada Council for the Arts

The RAIC submitted a brief to the Canada Council for the Arts during their strategic planning consultations. Among the suggestions, the RAIC indicated that Architecture was under funded and not visible in comparison to the other arts.

The RAIC continues to build on its partnership with the CCA for the administration of the Governor General's Medals in Architecture.

International Affairs

Federación des Colegios des Arquitectos de la República Mexicana (FCARM)

In November 2007, the RAIC President **Kiyoshi Matsuzaki, FRAIC** and Executive Director, **Jon Hobbs, FRAIC** attended the annual assembly of FCARM in Chetumal, Mexico. The visit also provided an opportunity to discuss and plan for the future APEC Meeting in Vancouver, as the Mexicans now host the Secretariat for the APEC Architect Project.

2007 Foundation Awards

Canada Green Building Council Scholarship for Sustainable Design and Research

This scholarship was established through an endowment from the Canada Green Building Council (CaGBC) in June 2006. The main purpose of the fund is to nurture the next generation of
